Funds and plans for the bridge project and road work on phase one of the 638 Highway project are on schedule for 2018.

<u>Planning Commission</u> – Mitchell L. Mulka

Minutes were filed for a public hearing held on November 28, 2016, by request of Sand Bay Marina. Sand Bay Marina is requesting a special use permit for a Laundromat, boat showroom and repair service at US-23 S and 638 Highway. Their site plan was approved with a recommendation that the security fence and lockable gate requirement be reviewed for removal (Article XIII 29 D). If the recommendation is denied, the Marina shall comply with the ordinance within one year of date of denial. The Planning Commission will need to schedule a public hearing to review Article XIII 29 D.

Posen Area Fire Department Authority – Michael T. Smith

Mr. Smith filed the minutes of November 2, 2016. The County Commissioners will apply for a 1.2 million dollar FEMA grant for pagers and radios. The grant will be funded by the 911 surcharge over ten years.

The Posen Area Fire Department has received their turnout gear, washer/dryer, and an infrared camera. Another FEMA grant has been written to purchase new hoses for all the fire trucks.
